RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF HEAVY-DUTY PLATFORM TROLLEY - REBID TO RDSK FURNITURE SUPPLY WITH A TOTAL BID AMOUNT OF TWENTY-ONE THOUSAND FIVE HUNDRED FOUR PESOS (Php21,504.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Heavy-Duty Platform Trolley-Rebid with an approved budget for the contract of Twenty-Four Thousand Four Hundred Pesos (Php24,400.00).

WHEREAS, several prospective bidders were also requested through e-mail to submit quotation for the project and prior to the deadline for submission and opening of bids, three (3) bidders submitted their quotations, namely: RDSK Furniture Supply (RDSK), Perry A Trading Corp. (Perry A), and Justic Corporation (Justic).

WHEREAS, on 28 October 2022, during the evaluation of bids, using a non-discretionary “pass/fail” criterion, Perry A was disqualified due to its failure to submit its Omnibus Sworn Statement, while RDSK and Justic both passed the eligibility and technical evaluation, with the following financial bid quotations:

1. RDSK – Php21,504.00
2. Justic – Php12,000.00

WHEREAS, Justic was declared as Lowest Calculated Bidder and was subjected to post-qualification.

WHEREAS, on 3 November 2022, during the Post-Qualification, Justic was able to present the original copy of its bid documents submitted during the opening of bids. The BAC together with the end-user examined the trolley brought by Justic and noted the following observations:

1. During the actual test, it was observed that the two (2) caster wheels were slightly deformed when ten (10) boxes of copy paper with 15 kilos each were loaded to the trolley.
2. It was also observed that the trolley was hard to push with the said load.

WHEREAS, on the same day, the BAC declared Justic post disqualified under Resolution No. 118, series of 2022 dated November 15, 2022. The BAC then send a Notice of Post Qualification to RDSK as the Second Lowest Calculated Bidder.


WHEREAS, on December 13, 2022, a post-qualification was conducted at the BAC Conference Room, PRC Central Office, located at 4th Floor of the PRC Annex Building. RDSK was able to present the original copies of the eligibility and technical documents they have submitted during the opening of bids and the sample trolley to be

delivered was subjected to testing by the BAC and the end-user. It was declared that the same was compliant with the Terms and Reference for the said project.


WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby **RESOLVED**, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: **PROCUREMENT OF HEAVY-DUTY PLATFORM TROLLEY – REBID TO RDSK FURNITURE SUPPLY WITH A TOTAL BID AMOUNT OF TWENTY-ONE THOUSAND FIVE HUNDRED FOUR PESOS (Php21,504.00).**
