**RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE
PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT
FOR THE PROJECT: PROCUREMENT OF ACCESS POINT WITH TOTAL BID
AMOUNT OF EIGHTY-FOUR THOUSAND PESOS (Php84,000.00)**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Access Point with an approved budget for the contract of One Hundred Eight Thousand Two Hundred Forty Pesos (Php108,240.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, two (2) bidders participated and submitted their eligibility, technical, and financial proposals, namely, The Value Systems Integration Inc. (Value Systems) and BayanPC Technologies Inc. (BayanPC).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".


WHEREAS, on 9 November 2022, during the opening and evaluation of bids, using a non-discretionary "pass/fail" criterion, BayanPC was declared disqualified for failure to submit a duly notarized Secretary's Certificate and failure to conform to the technical specification in the Terms of Reference (Annex "A"), while the Value Systems passed the eligibility and technical evaluation with a financial bid of Eighty-Four Thousand Pesos (Php84,000.00).


WHEREAS, Value Systems was declared to be the Single Calculated and Responsive Bidder.


WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: **PROCUREMENT OF ACCESS POINT to THE VALUE SYSTEMS INTEGRATION INC.** with the total bid amount of **EIGHTY-FOUR THOUSAND PESOS (Php84,000.00)**.
