## RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT FOR THE PROJECT: PROCUREMENT OF CUSTOMIZED JACKET AS TOKEN FOR THE DELEGATES OF PROFESSIONAL TEACHERS INTERNATIONAL CONFERENCE UNDER THE INTERNATIONAL COMMITMENTS FUND (ICF) 2022 TO ALPHA QUALITY EXPRESS INC. WITH TOTAL BID AMOUNT OF THREE HUNDRED EIGHTY-TWO THOUSAND FIVE HUNDRED PESOS (Php382,500.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website and social media account of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Customized Jacket as Token for the Delegates of Professional Teachers International Conference Under the International Commitments Fund (ICF) 2022 with an approved budget for the contract of Four Hundred Seventy-Two Thousand Pesos (Php472,000.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, four (4) bidders participated and submitted their eligibility, technical, and financial proposals, namely, TJK Garment (TJK), Cool Ads Design & Prints Inc. (Cool Ads), Karen International Inc. (Karen Int'l), and Alpha Quality Express Inc., (AQEI).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on 16 November 2022, during the opening and evaluation of bids, using a non-discretionary "pass/fail" criterion, TJK, Cool Ads and Karen Int'l. were declared disgualified due to the following reasons:

- 1. TJK failed to submit the Omnibus Sworn Statement, the conformity with Terms of Reference (Annex "A") and duly accomplished Financial Bid in the Official Bid Form (Annex "B");
- Cool Ads' Omnibus Sworn Statement (OSS) has a discrepancy, the name stated in the OSS is different from the one who signs the same name and it failed to submit the Secretary's Certificate, thus, the person signed the Terms of Reference (Annex "A") and Financial Bid (Annex "B"), has no authority to represent the corporation; and
- 3. Karen Int'l failed to submit the duly signed Secretary's Certificate;

**WHEREAS,** AQEI passed the eligibility and technical evaluation, with a financial bid quotation of Three Hundred Eighty-Two Thousand Five Hundred Pesos

(Php382,500.00) was declared to be the Single Calculated Bidder and was subjected to post-qualification as requested by the end-user.

WHEREAS, a post-qualification was conducted on 17 November 2022 at the Professional Regulation Commission, BAC Conference Room, 4<sup>th</sup> Floor, Annex Building where the original copies of the eligibility and technical documents submitted during the opening of bids were presented for validation with the sample of the jacket.

WHEREAS, AQEI, passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: PROCUREMENT OF CUSTOMIZED JACKET AS TOKEN FOR THE DELEGATES OF PROFESSIONAL TEACHERS INTERNATIONAL CONFERENCE UNDER THE INTERNATIONAL COMMITMENTS FUND (ICF) 2022 to ALPHA QUALITY EXPRESS INC. with the total bid amount of THREE HUNDRED EIGHTY-TWO THOUSAND FIVE HUNDRED PESOS (Php382,500.00).
