**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF LATEX GLOVES – REBID TO JACA OFFICE AND SCHOOL SUPPLIES TRADING WITH TOTAL BID AMOUNT OF TWENTY-ONE THOUSAND ONE HUNDRED FIFTY PESOS (Php21,150.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Latex Gloves – Rebid with an approved budget for the contract of Thirty-One Thousand One Hundred Fourteen Pesos (Php31,114.00).

**WHEREAS**, on March 25, 2022, during the schedule of submission and opening of bids, only one bidder submitted its quotations, namely: JACA Office and School Supplies Trading (JACA Office).

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

**WHEREAS**, upon evaluation of the submitted eligibility documents using a non-discretionary “pass/fail” criterion, JACA Office passed the eligibility and technical evaluation with financial bid quotation amounting to Twenty-One Thousand One Hundred Fifty Pesos (Php21,150.00).

**WHEREAS**, JACA Office was declared as the Single Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: **PROCUREMENT OF LATEX GLOVES – REBID to JACA OFFICE AND SCHOOL SUPPLIES TRADING** with total bid amount of **TWENTY-ONE THOUSAND ONE HUNDRED FIFTY PESOS (Php21,150.00)**.
