RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF PRC SUPER ADHESIVE SEALING TAPE TO VICFANIA TRADING WITH TOTAL BID AMOUNT OF ONE HUNDRED NINETY-ONE THOUSAND THREE HUNDRED SEVENTY-SIX PESOS AND FIFTEEN CENTAVOS (Php191,376.15)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of PRC Super Adhesive Sealing Tape with an approved budget for the contract of Three Hundred Thirty-Eight Thousand Two Hundred Twenty Pesos (Php338,220.00).

WHEREAS, on April 8, 2022, during the schedule of submission and opening of bids, four (4) bidders submitted their quotations, namely: Titus118 Non-Specialized Wholesale Trading (Titus118), Vicfania Trading (Vicfania), J1TEK Trading Corporation (J1TEK) and Double N Prime Enterprises, OPC (Double N Prime).

WHEREAS, upon evaluation of the submitted eligibility documents using a nondiscretionary "pass/fail" criterion, J1TEK and Double N Prime were declared disqualified due to the following reasons:

- 1. J1TEK failed to submit a valid (unexpired) Mayor's Permit and duly notarized Secretary's Certificate;
- 2. Double N Prime failed to submit a duly notarized Secretary's Certificate

WHEREAS, Titus118 and Vicfania both passed the eligibility and technical evaluation, with the following financial bid quotations:

- 1. Titus118 Php259,302.00
- 2. Vicfania Php191,376.15

WHEREAS, Vicfania was declared as the Lowest Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: PROCUREMENT OF PRC SUPER ADHESIVE SEALING TAPE to VICFANIA TRADING with total bid amount of ONE HUNDRED NINETY-ONE THOUSAND THREE HUNDRED SEVENTY-SIX PESOS AND FIFTEEN CENTAVOS (Php191,376.15).
