Resolution No. 2022 - 27

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE SUPPLY AND DELIVERY OF VARIOUS PRC PLAQUES TO ALPHA QUALITY EXPRESS INC. WITH TOTAL BID AMOUNT OF ONE HUNDRED NINETY THOUSAND PESOS (Php190,000.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various PRC Plaques with an approved budget for the contract of Two Hundred Twelve Thousand Seven Hundred Pesos (Php212,700.00).

WHEREAS, on April 20, 2022, during the schedule of submission and opening of bids, two (2) bidders submitted their quotations, namely: Rivera Mastercraft (Rivera) and Alpha Quality Express Inc. (AQEI).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, upon evaluation of the submitted eligibility documents using a non-discretionary "pass/fail" criterion, Rivera was declared disqualified for failing to submit the Terms of Reference (Annex "A") and the Financial Bid submitted was not in the Official Bid Form (Annex "B") while AQEI passed the eligibility and technical evaluation with a financial bid of One Hundred Ninety Thousand Pesos (Php190,000.00).

WHEREAS, AQEI was declared as the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: SUPPLY AND DELIVERY OF VARIOUS PRC PLAQUES to ALPHA QUALITY EXPRESS INC. with total bid amount of ONE HUNDRED NINETY THOUSAND PESOS (Php190,000.00).
