BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 31

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF TABLET DEVICE TO AVID SALES CORPORATION WITH TOTAL BID AMOUNT OF ONE HUNDRED FORTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (Php148,800.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Tablet Device with an approved budget for the contract of One Hundred Fifty-Two Thousand Pesos (Php152,000.00).

WHEREAS, on April 20, 2022, during the schedule of submission and opening of bids, five (5) bidders submitted their quotations, namely: The Value Systems Integration Inc. (Value Systems), Ablaze Marketing (Ablaze), World Solution Technology Inc. (World Solution), BAYANPC Technologies Inc. (BAYANPC), and Avid Sales Corporation (Avid Sales).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, upon evaluation of the submitted eligibility documents using a nondiscretionary "pass/fail" criterion, Value Systems, Ablaze, World Solution, and BAYANPC were declared disqualified due to the following reasons:

- 1. Value Systems and Ablaze failed to submit a duly notarized Secretary's Certificate;
- 2. BAYANPC failed to submit a Secretary's Certificate; and
- 3. World Solution submitted two (2) bid price quotations.

WHEREAS, only Avid Sales passed the eligibility and technical evaluation, with a financial bid quotation of One Hundred Forty-Eight Thousand Eight Hundred Pesos (Php148,800.00).

WHEREAS, Avid Sales was declared as the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission for his approval the award of the contract for the project: PROCUREMENT OF TABLET DEVICE to AVID SALES CORPORATION with total bid amount of ONE HUNDRED FORTY-EIGHT THOUSAND EIGHT HUNDRED PESOS (Php148,800.00).
