**DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF TONER
CART, SAMSUNG MLT-D205L, BLACK (GENUINE)-REBID WITH A TOTAL
APPROVED BUDGET FOR THE CONTRACT OF TWO HUNDRED SEVENTY-NINE
THOUSAND FOUR HUNDRED PESOS (PHP 279,400.00) THROUGH NEGOTIATED
PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Toner Cart, Samsung MLT-D205L, Black (Genuine)-Rebid with an approved budget for the contract of Two Hundred Seventy-Nine Thousand Four Hundred (Php 279,400.00) only.

WHEREAS, during the scheduled deadline and submission of bid proposals on May 6, 2022, two (2) bidders participated and submitted its eligibility and technical requirements, namely: ANDJ BRIGHT PRINTING SERVICES and ERIVAN GENERAL MERCHANDISE.

WHEREAS, during the opening and evaluation of bid, ERIVAN GENERAL MERCHANDISE failed to submit a Certification from the Manufacturer on the authenticity of the product and the Special Power of Attorney for its authorized representative and likewise failed to present the sample of the offered product as required in the Request for Quotation; meanwhile, ANDJ BRIGHT PRINTING SERVICES failed to include the Conformity with the Terms of Reference (Annex “A”), to present the sample of the offered product, and to submit the Special Power of Attorney for the authorized representative and a Certification from the Manufacturer on the authenticity of the product. Therefore, both the bidders were marked as failed in complying with the Terms of Reference.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, Section 35, Rule X of the 2016 Revised IRR provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;**

c) All bids fail to comply with all the bid requirements or post-qualification, or x xxx (Emphasis supplied)

WHEREAS, Section 35. 2 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR.(a) (underscoring supplied)


WHEREFORE, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to **DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF TONER CART, SAMSUNG MLT-D205L, BLACK (GENUINE)-REBID** with a total approved budget for the contract of **TWO HUNDRED SEVENTY-NINE THOUSAND FOUR HUNDRED PESOS (PHP 279,400.00)**. Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
