DECLARATION OF FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022 - LOT 1 TO 3 WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF ONE HUNDRED FORTY-ONE THOUSAND NINE HUNDRED THIRTY-THREE PESOS AND THIRTY CENTAVOS (PHP141,933.30) THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission and at the Bids Awards Committee (BAC) Bulletin Board, for the project: Supply and Delivery Of Various Tokens And Awards For The PRC Awardees 2022 - Lot 1 To 3 with an approved budget for the contract of One Hundred Forty-One Thousand Nine Hundred Thirty-Three Pesos and Thirty Centavos (Php141,933.30) only.

**WHEREAS**, during the scheduled deadline and submission of bid proposals on June 22, 2022, no bidder submitted its bid proposal.

**WHEREAS,** Section 35, Rule X of the 2016 Revised IRR provides for the authority of the BAC to declare a failure of bidding in cases where no bidders responded to the request for quotation, to wit:

## Section 35. Failure of Bidding

35.1 The BAC shall declare the bidding a failure when:

- a) No bids are received;
- b) All prospective bidders are declared ineligible;
- c) All bids fail to comply with all the bid requirements or postqualification, or x xxx (Emphasis supplied)

**WHEREAS**, Section 35. 2 and 35.3 of the same IRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

- 35.2. In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.
- 35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of this IRR.(a) (underscoring supplied).

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022 - LOT 1 TO 3 with a total approved budget for the contract of ONE HUNDRED FORTY-ONE THOUSAND NINE HUNDRED THIRTY-THREE PESOS AND THIRTY CENTAVOS (PHP141,933.30). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.
