

**CONTRACT AGREEMENT FOR
PROVISION OF INTERNET CONNECTION AND IP VPN UPGRADE**

CS-07-2022-50 dated July 22, 2022

THIS AGREEMENT made the _____ day of JUL 22 2022 20____ between **PROFESSIONAL REGULATION COMMISSION** (hereinafter called "the Entity") of the one part and **PLDT, INC.** of Ramon Cojuanco Building, Makati Avenue, Makati City, Philippines (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the Provision of Internet Connection and IP VPN Upgrade and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Eighteen Million Pesos (Php18,000,000.00) only. (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Request for Quotation (RFQ);
 - i. Terms and Conditions (Annex A)
 - ii. Price Quotation Sheet Financial Bid (Annex B);
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
3. In consideration for the sum of **Eighteen Million Pesos (Php18,000,000.00)** or such other sums as may be ascertained, PLDT, Inc. agrees to provide the goods and services and to remedy defects therein in conformity, in all respects, with the Terms of Reference in accordance with his/her/its Bid.
4. The Professional Regulation Commission agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
5. The duration of this contract shall be from May 25, 2022 to May 24, 2023.
6. If Professional Regulation Commission continues to avail of the service after expiration of this contract, said extension of contract shall be understood as running from month to month only, under the same terms and condition herein stipulated, and may be terminated by either party by means of written notice served upon the other party at least one (1) month in advance prior to the date of such termination and until a new contract is awarded or approved.

7. The PLDT, Inc. shall post a performance security prior to the signing of this Contract denominated in the Philippine Peso in favor of the PRC, in any of the prescribed form under the 2016 Revised R.A. 9184, and in an amount not less than the required percentage of the total contract price.

PROVISION OF INTERNET CONNECTION AND IP VPN UPGRADE (Through Negotiated Procurement Pursuant to Section 53.9 of the 2016 Revised Implementing Rules and Regulations of R.A. 9184)

I. APPROVED BUDGET FOR THE CONTRACT

The supplier shall bid for the item described in this Terms of Reference, which shall not exceed the Approved Budget for the Contract (ABC) in the amount of Eighteen Million Pesos (Php18,000,000.00) inclusive of all applicable bank and government charges.


II. SPECIFICATION

A. Service Provider Requirements:

- i. BIDDER must certify that the cable facility being used in the connectivity between the bidder's circuits is exclusively owned and operated by the bidder; all last-mile facilities must be wired cable.
- ii. BIDDER must provide a certification that they are connected or subscribed to Tier 1 or Tier 2 networks or ISPs.
- iii. BIDDER must provide a certification that it uses its domestic nationwide network and operates its landing stations, at least 3 cable landing stations
- iv. BIDDER directly connects to the Asia Pacific and US Peering partners.
- v. BIDDER must provide a certification that its network platform is compliant with the latest MEF carrier Ethernet (2.0).
- vi. BIDDER must have at least 3 Cisco Certified Internetworking Expert, 8 MEF Carrier Ethernet Certified Professionals 2.0, and certified Project Management Professionals (PMP) Technical support personnel.
- vii. BIDDER must support or IPV6 ready and compliant.
- viii. BIDDER must provide a certification that it uses IPVPN Network that is supported by a nationwide Domestic Fiber Optic Backbone Network to ensure fast and reliable service across the nation and the bidder must own the facility.
- ix. BIDDER must provide SNMP Community string on every router.
- x. BIDDER must install or set up a new conduit in case the existing and/or new Service Center locations are not equipped in handling fiber-optic lines.





- ii. Subscription must include a modem, router, or any device that will convert the last mile facility (fiber or copper) to Ethernet or Fast Ethernet. Must include all necessary cables to interconnect and operate all equipment.
- iii. Must be layer 3 VPN based on Multi-Protocol Label Switching (MPLS) Technology and the bidder's serving nodes must be geographically dispersed.
- iv. The IPVPN nodes must be in Mesh Topology (multi-point to multi-point) to ensure dependability and resiliency and the bandwidth should be upgradable when required.
- v. The IPVPN solution must be able to deliver the Class of Service (CoS) feature, to segregate VoIP traffic and Business critical traffic from the rest. CoS capability should be delivered from one Customer Edge router up to the other and should be fully executed on a PE to PE (Provider Edge Router) basis within the provider's core infrastructure.
