Resolution No. 2022 - 38(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF STOCK CARD AND PROPERTY CARD - REBID TO DEPENDABLE PACKAGING AND PRINTING HOUSE CORPORATION WITH TOTAL BID AMOUNT OF FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS AND EIGHTY-FIVE CENTAVOS (Php45,826.85)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Procurement of Stock Card and Property Card - Rebid with an approved budget for the contract of Forty-Nine Thousand Five Hundred Eighty-Eight Pesos and Ninety-Four Centavos (Php49,588.94).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, only Dependable Packaging and Printing House Corporation (Dependable) participated and submitted its eligibility, technical, and financial proposal.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, on 14 June 2022, during the opening and evaluation of bids, Dependable passed the eligibility and technical evaluation with the financial bid quotations of Forty-Five Thousand Eight Hundred Twenty-Six Pesos and Eighty-Five Centavos (Php45,826.85), and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **PROCUREMENT OF STOCK CARD AND PROPERTY CARD - REBID to DEPENDABLE PACKAGING AND PRINTING HOUSE CORPORATION** with the total bid amount of **FORTY-FIVE THOUSAND EIGHT HUNDRED TWENTY-SIX PESOS AND EIGHTY-FIVE CENTAVOS (Php45,826.85)**.
