DECLARATION OF SECOND FAILURE OF BIDDING FOR THE PROJECT SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022 (LOT 1 TO 3) – REBID THROUGH NEGOTIATED PROCUREMENT UNDER SECTION 53.9 – SMALL VALUE PROCUREMENT

WHEREAS, the bidding for the project: Supply and Delivery of Various Tokens and Awards for the PRC Awardees 2022 (Lot 1 To 3) – Rebid was declared for the first time as failed on June 22, 2022, through the approved Bids and Awards Committee (BAC) Resolution No. 2022-43.

WHEREAS, the BAC caused the re-posting of the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project with an approved budget for the contract in the amount of One Hundred Forty-One Thousand Nine Hundred Thirty-Three Pesos and Thirty Centavos (Php141,933.30).

WHEREAS, on June 24, 2022, several prospective bidders were requested through e-mail to submit quotation for the project.

WHEREAS, on June 27, 2021, the BAC issued Bid Bulletin No. 1 (ANNEX “A”) with regards to the new schedule of Submission and Opening of Bids. The said Bid Bulletin was posted in PhilGEPS, PRC Website and BAC Bulletin Board.

WHEREAS, during the scheduled deadline and submission of bid proposals on July 1, 2022, no bidder submitted its bid proposal.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) states for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

35.1 *The BAC shall declare the bidding a failure when:*

- a) No bids are received;**
- b) All prospective bidders are declared ineligible;*
- c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)*

WHEREAS, Section 35. 2 and Section 35.3 of the same RIRR provides for the steps and procedures that the BAC should take in case of failure of bidding; x x x to wit:

35.2. *In order to determine the reason for the failed bidding, the BAC shall conduct a mandatory review and evaluation of the terms, conditions, and specifications in the Bidding Documents, including its cost estimates.*

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with re-advertisement and/or posting, as provided for in Section 21.2 of this IRR. (underscoring supplied)

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it is hereby RESOLVED, to DECLARE A SECOND FAILURE OF BIDDING FOR THE PROJECT SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022 (LOT 1 TO 3) – REBID through negotiated procurement under section 53.9 – Small Value Procurement with an approved budget for the contract of One Hundred Forty-One Thousand Nine Hundred Thirty-Three Pesos and Thirty Centavos (Php141,933.30). Consequently, the BAC shall conduct a re-bidding with re-advertisement and/or posting of said procurement project.

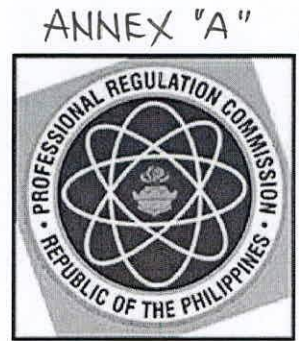




