**Resolution No. 2022 - 60**

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF SPORTSWEAR UNIFORMS TO RBQ METAL STAMPING ENTERPRISES WITH A TOTAL BID AMOUNT OF THREE HUNDRED THIRTY-FOUR THOUSAND FOUR HUNDRED PESOS (Php334,400.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Sportswear Uniforms with an approved budget for the contract of Three Hundred Ninety-Five Thousand and Eighty Pesos (Php395,080.00) only.

**WHEREAS**, on July 8, 2022 during the schedule of submission and opening of bids, only one bidder submitted its quotations, namely: RBQ Metal Stamping Enterprises (RBQ).

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

**WHEREAS**, upon evaluation of the submitted eligibility documents using a non-discretionary “pass/fail” criterion, RBQ passed the eligibility and technical evaluation with financial bid quotation amounting to Three Hundred Thirty-Four Thousand Four Hundred Pesos (Php334,400.00)

**WHEREAS**, RBQ was declared as the Single Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT OF SPORTSWEAR UNIFORMS TO RBQ METAL STAMPING ENTERPRISES** with the bid amount of **THREE HUNDRED THIRTY-FOUR THOUSAND FOUR HUNDRED PESOS (Php334,400.00)**.


