Resolution No. 2022 49

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022: LOT 1 – FIFTY (50) PIECES VARIOUS TROPHIES – REBID TO E&C GENERAL MERCHANDISE WITH TOTAL BID AMOUNT OF ONE HUNDRED SEVENTY THOUSAND PESOS (Php170,000.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Various Tokens and Awards for the PRC Awardees 2022: Lot 1 – Fifty (50) Pieces Various Trophies – Rebid with an approved budget for the contract of Two Hundred Seven Thousand Thirty-Three Pesos and Thirty-One Centavos (Php207,033.31).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, two (2) bidders participated and submitted its eligibility, technical, and financial proposal, namely, E&C General Merchandise (E&C) and Alpha Quality Express Inc. (AQEI).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

WHEREAS, on 11th of July 2022, during the opening and evaluation of bids, AQEI failed to submit their Mayor's/Business Permit and PhilGEPS Registration Number, the signed Omnibus Sworn Statement and Secretary's Certificate, thereby receiving failed mark on the evaluation sheet, while E&C passed the eligibility and technical evaluation with the financial bid quotation of One Hundred Seventy Thousand Pesos (Php170,000.00), and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022: LOT 1 – FIFTY (50) PIECES VARIOUS TROPHIES – REBID to E&C GENERAL MERCHANDISE** with the total bid amount of **ONE HUNDRED SEVENTY THOUSAND PESOS (Php170,000.00)**.
