**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022: LOT 3 – ONE (1) SET TRINKET AND MEDALLION WITH WOODEN BOX – REBID TO E&C GENERAL MERCHANDISE WITH TOTAL BID AMOUNT OF SIXTEEN THOUSAND PESOS (Php16,000.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, and at the Bids and Awards Committee (BAC) Bulletin Board for the project: Supply and Delivery of Various Tokens and Awards for the PRC Awardees 2022: Lot 3 – One (1) Set Trinket and Medallion with Wooden Box – Rebid with an approved budget for the contract of Sixteen Thousand Pesos (Php16,000.00).

**WHEREAS**, several service providers were also requested through e-mail to submit quotation for the project.

**WHEREAS**, prior to the deadline for submission and opening of bids, only one (1) bidder participated and submitted its eligibility, technical, and financial proposal, namely, E&C General Merchandise (E&C).

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

**WHEREAS**, on 11<sup>th</sup> of July 2022, during the opening and evaluation of bids, E&C passed the eligibility and technical evaluation with the financial bid quotation of Sixteen Thousand Pesos (Php16,000.00), and was declared to be the Single Calculated and Responsive Bidder.

**WHEREFORE**, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **SUPPLY AND DELIVERY OF VARIOUS TOKENS AND AWARDS FOR THE PRC AWARDEES 2022: LOT 3 – ONE (1) SET TRINKET AND MEDALLION WITH WOODEN BOX – REBID to E&C GENERAL MERCHANDISE** with the total bid amount of **SIXTEEN THOUSAND PESOS (Php16,000.00)**.
