BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 49(A)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF CUSTOMIZED PRC ANNIVERSARY POLO SHIRT TO ANCLAZE TRADING CORPORATION WITH TOTAL BID AMOUNT OF ONE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED SIXTY-TWO PESOS (PHP199,962.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Customized PRC Anniversary Polo Shirt with an approved budget for the contract of Two Hundred Sixty-Four Thousand Five Hundred Pesos (Php264,500.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, three (3) bidders participated and submitted its eligibility, technical, and financial proposal, namely, Hanaya Style Trading (Hanaya), Anclaze Trading Corporation (Anclaze) and Rulujac Enterprise (Rulujac Enterprise).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on 11th of July 2022, during the opening and evaluation of bids, Hanaya, Anclaze and Rulujac passed the eligibility and technical evaluation with the following financial bid quotations:

- 1. Hanaya Style Trading Php259,210.00
- 2. Anclaze Trading Corporation Php199,962.00
- 3. Rulujac Enterprise Php238,050.00

WHEREAS, Anclaze was declared to be the Lowest Calculated Bidder and was subjected to post-qualification as per request of the end-user.

WHEREAS, the post-qualification was conducted on July 12, 2022 at the BAC Conference Room, located at the 4th Floor of the PRC Annex Building and via videoconferencing, the original copies of the eligibility and technical documents submitted during the opening of bids was presented for validation with the sample of the polo shirt.

WHEREAS, Anclaze, passed the post-qualification, and was declared to be the Lowest Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: PROCUREMENT OF CUSTOMIZED PRC ANNIVERSARY POLO SHIRT to ANCLAZE TRADING CORPORATION with the total bid amount of ONE HUNDRED NINETY-NINE THOUSAND NINE HUNDRED SIXTY-TWO PESOS (PHP199,962.00).
