

In consideration of the sum of **One Hundred Ninety-Nine Thousand Nine Hundred Sixty-Two Pesos (Php199,962.00)** or such other sums as may be ascertained Anclaze Trading Corporation agrees to provide the goods and services and to remedy defects therein in conformity, in all respects, with the Terms of Reference in accordance with his/her/its Bid.
4. The Professional Regulation Commission agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
