Resolution No. 2022 - 68

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF OFFICE TABLE WITH PEDESTAL TO GAMMA LINE ENTERPRISES WITH TOTAL BID AMOUNT OF ONE HUNDRED FOUR THOUSAND ONE HUNDRED SIXTY PESOS (PHP104,160.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Office Table with Pedestal with an approved budget for the contract of One Hundred Forty-Six Thousand Eight Hundred Forty Pesos (Php146,840.00).

**WHEREAS**, several service providers were also requested through e-mail to submit quotation for the project.

**WHEREAS**, prior to the deadline for submission and opening of bids, four (4) bidders participated and submitted its eligibility, technical, and financial proposal, namely, Suntawood Home and Office Inc. (Suntawood), Doin Furniture Trading (Doin Furniture), Gamma Line Enterprises (Gamma Line), and New AG Stylist Furniture (New AG).

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, on 25 July 2022, during the opening and evaluation of bids, all four bidders passed the eligibility and technical evaluation with the following financial bid quotations:

1. Suntawood – Php142,000.00
2. Doin Furniture – Php136,000.00
3. Gamma Line – Php104,160.00
4. New AG – Php120,000.00

**WHEREAS**, Gamma Line was declared to be the Lowest Calculated Bidder and was subjected to post-qualification as per request of the end-user.

**WHEREAS**, a post-qualification was conducted on 26 July 2022 at the Gamma Line office located at the 16-M Maya Building, EDSA, Cubao, Quezon City where the


original copies of the eligibility and technical documents submitted during the opening of bids were presented for validation with the sample of the office table with pedestal.

**WHEREAS**, Gamma Line, passed the post-qualification, and was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the project: **PROCUREMENT OF OFFICE TABLE WITH PEDESTAL** to **GAMMA LINE ENTERPRISES** with the total bid amount of **ONE HUNDRED FOUR THOUSAND ONE HUNDRED SIXTY PESOS (PHP104,160.00)**.
