**RECOMMENDING TO THE ACTING CHAIRPERSON OF THE PROFESSIONAL
REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF
JUNIOR EXECUTIVE CHAIR TO NEW AG STYLIST FURNITURE WITH TOTAL
BID AMOUNT OF THREE HUNDRED TWELVE THOUSAND PESOS
(PHP312,000.00)**

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Junior Executive Chair with an approved budget for the contract of Six Hundred Twenty-Four Thousand Pesos (Php624,000.00).

WHEREAS, several service providers were also requested through e-mail to submit quotation for the project.

WHEREAS, prior to the deadline for submission and opening of bids, eight bidders participated and submitted its eligibility, technical, and financial proposal, namely, Luxenberg Marketing Inc. (Luxenberg), GL10 Consumer Goods Trading (GL10), Titus 118 Non-Specialized Wholesale Trading (Titus 118), Workswell Enterprises Inc. (Workswell), Taeyoung International Corp. (Taeyoung), New AG Stylist Furniture (New AG), Doin Furniture Trading (Doin), and Gemstone Enterprise (Gemstone).

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, on 7 September 2022, during the opening and evaluation of bid using a non-discretionary "pass/fail" criterion, Luxenberg, GL10, Titus 118, Workswell and Taeyoung were declared disqualified due to the following reasons:

1. Luxenberg failed to submit the Latest Income/Business Tax Return, Omnibus Sworn Statement, Request for Quotation Annexes "A" and "B" and duly notarized Secretary's Certificate;
2. GL10 failed to submit the Omnibus Sworn Statement;
3. Titus 118 failed to submit the Latest Income/Business Tax Return and Omnibus Sworn Statement;

4. Workswell failed to submit the Latest Income/Business Tax Return and Request for Quotation Annexes "A" and "B";
5. Taeyoung failed to submit the Latest Income/Business Tax Return, Omnibus Sworn Statement, and duly notarized Secretary's Certificate;

WHEREAS, New AG, Doin and Gemstone passed the eligibility and technical evaluation, with the following financial bid quotations:


1. New AG – Php312,000.00
2. Doin – Php566,800.00
3. Gemstone – Php374,400.00

WHEREAS, New AG was declared to be the Lowest Calculated and Responsive Bidder.


