BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 104

RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF BATTERY FOR DATA CENTER UNINTERRUPTED POWER SUPPLY TO EGM SYSTEMS GLOBAL TECHNOLOGIES INC. WITH A TOTAL BID AMOUNT OF SEVEN HUNDRED TWENTY-THREE THOUSAND THREE HUNDRED TWENTY-SIX PESOS (Php723,326.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Battery for Data Center Uninterrupted Power Supply (UPS) with an approved budget for the contract of Nine Hundred Fifty Thousand Pesos (Php950,000.00) only.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (RIRR) of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, during the scheduled deadline and submission of bid proposals on August 23, 2022, four (4) bidders submitted their quotations namely: SIM Computer Sales Inc., DGL Veracity Systems Corp., Equilast Inc., and EGM Systems Global Technologies Inc. (EGM).

WHEREAS, during the evaluation of bids, all bidders complied with the technical and financial requirements for the project with the following bid quotations:

- 1. SIM Computer Sales Inc.- Php750,000.00
- 2. DGL Veracity Systems Corp.- Php898,000.00
- 3. Equilast Inc.- Php347,660.00
- 4. EGM Systems Global Technologies Inc.- Php723,326.00

WHEREAS, Equilast Inc., was declared as the Lowest Calculated Bidder with the bid amount of Three Hundred Forty-Seven Thousand Six Hundred Sixty Pesos (Php347,660.00) and was subjected to Post-Qualification.

WHEREAS, on August 30, 2022, Equilast Inc. was subjected to post qualification, and was requested to present the original copies of the eligibility and technical documents and a sample product to ascertain, validate, and verify all statements made, and the documents submitted by the Bidder during the opening of bids. During the evaluation, Equilast Inc. did not present the original copies of its eligibility requirements and sample of the product due to unavailability of the authorized person and also failed to submit the Certificate for Authorized/Licensed Vertiv Engineer. Therefore, the BAC declared Equilast

Inc. as post-disgualified. A post-qualification with the Second Lowest Calculated Bidder, EGM was scheduled.

WHEREAS, on September 13, 2022, the BAC conducted a second postqualification with the Second Lowest Calculated Bidder, EGM. During the evaluation, EGM presented the original copies of its eligibility requirements and a sample product. They also submitted the Certificate for Authorized/Licensed Vertiv Engineer

WHEREAS, EGM was declared as the Second Lowest Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairperson of the Professional Regulation Commission, for her approval, the award of contract for the PROCUREMENT OF BATTERY FOR DATA CENTER UNINTERRUPTED POWER SUPPLY (UPS) to EGM SYSTEMS GLOBAL TECHNOLOGIES INC. with the bid amount of SEVEN HUNDRED TWENTY-THREE THOUSAND THREE HUNDRED TWENTY-SIX PESOS (Php723,326.00).
