**Resolution No. 2022 - 105**

**RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF TRASH BIN WITH PEDAL TO RAMESH TRADING CORPORATION WITH A TOTAL BID AMOUNT OF EIGHTEEN THOUSAND ONE HUNDRED FIFTY PESOS (Php18,150.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Supply and Delivery of Trash Bin with Pedal with an approved budget for the contract of Twenty-One Thousand Seven Hundred Fifty Pesos (Php21,750.00) only.

**WHEREAS**, on August 31, 2022 during the schedule of submission and opening of bids, only one bidder submitted its quotation, namely: Ramesh Trading Corporation (Ramesh)

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".


**WHEREAS**, upon evaluation of the submitted eligibility documents using a non-discretionary "pass/fail" criterion, Ramesh passed the eligibility and technical evaluation with financial bid quotation amounting to Eighteen Thousand One Hundred Fifty Pesos (Php18,150.00)


**WHEREAS**, Ramesh was declared as the Single Calculated and Responsive Bidder.


**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Acting Chairperson of the Professional Regulation Commission, for his approval, the award of contract for the **SUPPLY AND DELIVERY OF TRASH BIN WITH PEDAL TO RAMESH TRADING CORPORATION** with the bid amount of **EIGHTEEN THOUSAND ONE HUNDRED FIFTY PESOS (Php18,150.00)**.
