Resolution No. 2022- 93

**RECOMMENDING TO THE ACTING CHAIRPERSON OF THE PROFESSIONAL  
REGULATION COMMISSION, FOR HIS APPROVAL, THE PROCUREMENT OF  
FOLDING BED WITH MATTRESS TO NEW AG STYLIST FURNITURE WITH  
TOTAL BID AMOUNT OF ONE HUNDRED SEVEN THOUSAND THREE  
HUNDRED PESOS (PHP107,300.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Folding Bed with Mattress with an approved budget for the contract of One Hundred Fifty Eight Thousand Five Hundred Thirty Three Pesos and Forty Three Centavos (Php158,533.43).

**WHEREAS**, several service providers were also requested through e-mail to submit quotation for the project.

**WHEREAS**, prior to the deadline for submission and opening of bids, four (4) bidders participated and submitted its eligibility, technical, and financial proposal, namely, Workswell Enterprises Inc. (Workswell), Gamma Line Enterprises (Gamma Line), RighConn Enterprises (RighConn), and New AG Stylist Furniture (New AG),

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the “Government Procurement Reform Act”, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary “pass/fail” criterion. If a bidder submits the required document, it shall be rated “passed” for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as “failed”.

**WHEREAS**, on 13 September 2022, during the opening and evaluation of bid using a non-discretionary “pass/fail” criterion, Workswell failed to comply with the submission of their Omnibus Sworn Statement and their authorized representative as stated in their Secretary Certificate is different from the person who signed the Conformity with the Terms of Reference (Annex “A”) and the Duly accomplished Financial Bid in the Official Bid Form (Annex “B”). Therefore, Workswell was marked as failed.

**WHEREAS**, New AG, Gamma Line and RighConn passed the eligibility and technical evaluation, with the following financial bid quotations:


1. New AG – Php107,300.00
2. Gamma Line – Php143,260.00
3. RighConn – Php140,360.00

**WHEREAS**, New AG was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend to the Acting Chairperson of the Professional Regulation Commission, for his approval, the award of contract for the project: **PROCUREMENT OF FOLDING BED WITH MATTRESS to NEW AG STYLIST FURNITURE** with the total bid amount of **ONE HUNDRED SEVEN THOUSAND THREE HUNDRED PESOS (PHP107,300.00)**.
