**RECOMMENDING FOR THE APPROVAL OF THE CHAIRPERSON OF THE  
PROFESSIONAL REGULATION COMMISSION, THE AWARD OF CONTRACT  
FOR THE PROJECT: SUPPLY AND DELIVERY OF VARIOUS OFFICE  
FURNITURE: LOT 3 – OFFICE TABLE WITH DRAWERS TO NEW AG STYLIST  
FURNITURE WITH TOTAL BID AMOUNT OF THIRTY-SEVEN THOUSAND FIVE  
HUNDRED PESOS (Php37,500.00)**

**WHEREAS**, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, for the project: Supply and Delivery of Various Office Furniture: Lot 3 – Office Table with Drawers with an approved budget for the contract of Thirty-Nine Thousand Six Hundred Fifty-Eight Pesos and Thirty Centavos (Php39,658.30).

**WHEREAS**, several service providers were also requested through e-mail to submit quotation for the project.

**WHEREAS**, prior to the deadline for submission and opening of bids, only New AG Stylist Furniture (New AG) participated and submitted its eligibility, technical, and financial proposal.

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the "Government Procurement Reform Act", requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".


**WHEREAS**, on 20 September 2022, during the opening and evaluation of bid, New AG passed the eligibility and technical evaluation with the financial bid quotation of Thirty-Seven Thousand Five Hundred Pesos (Php37,500.00).


**WHEREAS**, New AG was declared to be the Single Calculated and Responsive Bidder.


**WHEREFORE**, the BIDS AND AWARDS COMMITTEE **RESOLVES**, as it hereby **RESOLVED**, to recommend for approval of the Chairperson of the Professional Regulation Commission, the award of contract for the project: SUPPLY AND DELIVERY OF VARIOUS OFFICE FURNITURE: LOT 3 – OFFICE TABLE WITH DRAWERS to NEW AG STYLIST FURNITURE with the total bid amount of THIRTY-SEVEN THOUSAND FIVE HUNDRED PESOS (Php37,500.00).
