## BIDS AND AWARDS COMMITTEE Resolution No. 2022 - 106

RECOMMENDING TO THE CHAIRPERSON OF THE PROFESSIONAL REGULATION COMMISSION, FOR HER APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT OF BRAND NEW FIRE/EMERGENCY EXIT DOORS TO OEM INDUSTRIAL PARTS AND CONSTRUCTION SERVICES CORPORATION WITH A TOTAL BID AMOUNT OF SIX HUNDRED TWENTY-NINE THOUSAND FOUR HUNDRED FORTY PESOS (Php629,440.00)

WHEREAS, the invitation to apply for eligibility and to bid through Negotiated Procurement under Section 53.9 – Small Value Procurement was posted in the website of the Commission, at the Bids and Awards Committee (BAC) Bulletin Board, and in the Philippine Government Electronic Procurement System (PhilGEPS) for the project: Procurement of Brand New Fire/Emergency Exit Doors with an approved budget for the contract of Six Hundred Fifty-Eight Thousand Pesos (Php658,000.00) only.

WHEREAS, on September 29, 2022 during the schedule of submission and opening of bids, one (1) bidder, OEM INDUSTRIAL PARTS AND CONSTRUCTION SERVICES CORPORATION (OEM) participated and submitted its eligibility and technical requirements.

WHEREAS, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, known as the Government Procurement Reform Act, requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, upon evaluation of the submitted eligibility documents using a non-discretionary "pass/fail" criterion, OEM passed the eligibility and technical evaluation with financial bid quotation amounting to Six Hundred Twenty-Nine Thousand Four Hundred Forty Pesos (Php629,440.00).

WHEREAS, OEM was declared as the Single Calculated Bidder and is subjected to post-qualification.

WHEREAS, on October 4, 2022, OEM was subjected to post qualification, and was requested to present the original copies of the eligibility and technical documents and a sample product to ascertain, validate, and verify all statements made, and the documents submitted by the Bidder during the opening of bids. During the evaluation, OEM presented the original copies of their eligibility requirements and sample of the product.

WHEREAS, OEM was declared as the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairperson of the Professional Regulation Commission, for her approval, the award of contract for the PROCUREMENT OF BRAND NEW FIRE/EMERGENCY EXIT DOORS to OEM INDUSTRIAL PARTS AND CONSTRUCTION SERVICES CORPORATION with the bid amount of SIX HUNDRED TWENTY-NINE THOUSAND FOUR HUNDRED FORTY PESOS (Php629,440.00).
