RECOMMENDING TO THE HEAD OF THE PROCURING ENTITY TO RESORT TO NEGOTIATED PROCUREMENT PURSUANT TO SECTION 53.10 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF THE GOVERNMENT PROCUREMENT REFORM ACT AND ENGAGE THE SERVICES AND FACILITIES OF SKYRISE HOTEL AND RESTAURANT AS ADDITIONAL EXAMINATION VENUE FOR THE CONDUCT OF LICENSURE EXAMINATION FOR MEDICAL TECHNOLOGISTS ON MARCH 13 AND 14, 2019 IN THE AMOUNT OF FORTY-SIX THOUSAND PESOS (PhP46,000.00)

WHEREAS, the Professional Regulation Commission (PRC) will be conducting Licensure Examination for Medical Technologists on March 13 and 14, 2019;

WHEREAS, the PRC Cordillera Administrative Region requested various schools and universities to allow PRC to use their schools as venue for the said examination;

WHEREAS, considering that the scheduled dates fall on weekdays and that classes are on-going, schools and universities are not available, which resulted in the procurement of additional venue to accommodate the said examination;

WHEREAS, Requests for Quotation were sent to three (3) prospective venues and all three (3) submitted their Price Quotation Sheets;

WHEREAS, based on Request for Quotation submitted, the Skyrise Hotel and Restaurant submitted the Lowest Calculated Quotation in the amount of Forty-six Thousand Pesos (PhP46,000.00);

WHEREAS, during the evaluation of requirements, Skyrise Hotel and Restaurant has complete documentary requirements of Business Permit (Annex A), Income Tax Return (Annex B) and PhilGEPS Registration (Annex C);

WHEREAS, Westfields Residences Inc. was disqualified having submitted less than the required capacity of 378 examinees. EGI Albergo Inc. was also disqualified having submitted a price quotation beyond the Approved Budget for the Contract;

WHEREAS, Skyrise Hotel and Restaurant was rated Passed based on the Table of Rating Factors for Lease of Venue and declared as the Lowest Calculated and Responsive Quotation;

WHEREFORE, the **RBAC RESOLVES**, as it hereby **RESOLVED**, to recommend to the Head of the Procuring Entity to resort to Negotiated Procurement pursuant to Section 53.10 of the 2016 Revised Implementing Rules and Regulations of the Government Procurement Reform Act and engage the services and facilities of Skyrise Hotel and Restaurant as additional examination venue for the conduct of Licensure Examination for Medical Technologists on March 13 and 14, 2019 in the amount of Forty-six Thousand Pesos (PhP46,000.00)
