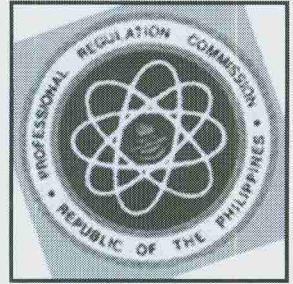
❖ TERMS AND COPNDITIONS

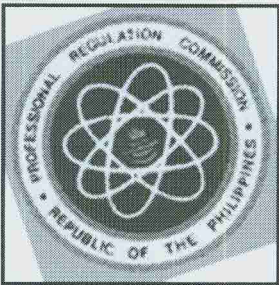

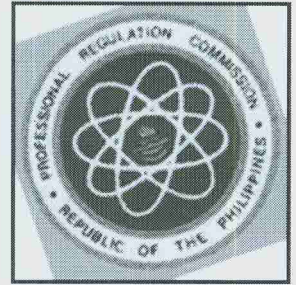
