- The examinees are required to inform the PRC Region I through email ([ro1.examination@prc.gov.ph](mailto:ro1.examination@prc.gov.ph)) or call (**0970 642 8217**), if they are showing any flu-like symptoms such as fever, cough and/or colds at least a day before the examination day. They shall be advised to defer taking the licensure examination but shall be allowed to take the next scheduled licensure examination without forfeiture of their payments.
- Examinees are **PROHIBITED** to **BRING** cellular phones inside the examination premises and to open/read books, notes, review and other printed materials containing coded data/information/formula for the **entire** examination period, **even during breaktime**.
