 - No OB-Gyne Clearance, No Exam.
- Bring food and water. It must be put in transparent 7. containers.
 - Food deliveries are not allowed. **
 - Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.

IMPORTANT REMINDERS

- Examinees are prohibited to use ALL KINDS OF CALCULATORS, Apple and 1. Samsung Smart Watches, cellular phones, ear plugs, transmitters, portable computers, bluetooth, and other electronic gadgets/devices. Examinees will be required to TURN OFF their mobile phone/s before entering the examination venue. Phone/s must be placed inside their bags and can only be used again upon exiting the venue;
- Books, notes, review materials, and other printed materials containing coded 2. data/information/formula are not allowed inside the testing center premises.
