## PHYSICAL THERAPISTS LICENSURE EXAMINATION 05 and 06 JUNE 2025

Relative to this, all examinees of Davao City are required to bring the following:

1. Notice of Admission
2. Two (2) or more pencils (No. 2)
3. Ball pens with BLACK ink only
4. One (1) piece long brown envelope
5. One (1) piece long transparent / plastic envelope (for keeping your valuables and other allowed items).
6. For pregnant examinee, submit clearance from the OB-Gynecologists
  - ❖ Clearance should indicate that the examinee is cleared to take the licensure examination.
  - ❖ No OB-Gyne Clearance, No Exam.
7. Bring food and water. It must be put in transparent containers.
  - ❖ Food deliveries are not allowed.
  - ❖ Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.





## PHYSICAL THERAPISTS LICENSURE EXAMINATION 05 and 06 JUNE 2025

### IMPORTANT REMINDERS

1. Examinees are prohibited to bring and use ALL KINDS OF CALCULATORS, SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH, and other electronic gadgets/devices which may store or retrieve data/information and/or to communicate for whatever purposes;
2. Books, notes, review materials, and other printed materials containing coded data/information/formula are not allowed inside the testing center premises.
3. Bags of any kind (ladies' bag, shoulder bags, attaché case, backpacks, etc.) and other examination aides not stated in this program are prohibited.
4. Bringing of the above said items inside the examination venue will be considered as **CHEATING** or an **ACT OF DISHONESTY**. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examinations
5. Report to the school/building assignment before 5:30am on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
6. Examinees are required to wear their school uniforms.
7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.
8. Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools. Tumblers may be used but subject for inspection.
9. Personal belongings brought by an examinee shall be for his/her own account. The PRC will not be answerable for any such item or personal belonging that might be lost during the examination without fault or negligence on its part.

2. Report to the school/building assignment before 5:30 a.m. on the first day of examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
3. Examinees are required to wear their school uniforms.
4. Bring the following on examination day:
  - a. Notice of Admission
  - b. Official Receipt
  - c. Two (2) or more pencils (No. 2)
  - d. Ball pens with **BLACK ink only**
  - e. One (1) piece long brown envelope
  - f. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)
5. The following are **PROHIBITED** inside the examination premises/rooms.
  - a. Books, notes, review materials, and other printed materials containing coded data/information/formula
  - b. **ALL KINDS OF CALCULATORS**
  - c. **APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES.**
  - d. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc)
  - e. Other examination aides not stated in this program.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.
