# 26-28 FEBRUARY 2025 COMPUTER-BASED LICENSURE EXAMINATION FOR SANITARY ENGINEERS

Relative to this, all examinees of Davao City are required to bring the following:

- 1. Notice of Admission
- 2. One (1) piece metered-stamped window mailing envelope purchased from PHILPost
- 3. Two (2) or more pencils (No. 2)
- 4. Ball pens with <u>BLACK ink only</u>
- 5. One (1) piece long brown envelope
- 6. One (1) piece long transparent / non-colored plastic envelope (for keeping your valuables and other allowed items).
- 7. Non-programmable calculator. (Please refer to Commission Resolution No. 1809 (s. 2024) or the "Updated List of Non-Programmable Calculators Allowed to be used in the Licensure Examinations").

NOTE: Only one (1) basic calculator shall be allowed inside the examination room. All calculators shall be inspected and have to be reset before the start of the examination.

7. For pregnant examinee, submit clearance from the OB-Gynecologists

Clearance should indicate that the examinee is cleared to take the licensure examination.

- No OB-Gyne Clearance, No Exam.
- 8. Bring food and water. It must be put in transparent containers.

Food deliveries are not allowed.

Schools, review center, co-examinees, or any other groups are not allowed to distribute food or drinks outside or inside the testing center premises, even during break time.

# **IMPORTANT REMINDERS**

- 1. Examinees are prohibited to use CALCULATORS which are programmable or calculators that can automatically carry out a sequence of operations under control of a stored program, much like a computer and/or with audio-visual features, and/ or capable of external communication or internet connectivity specifically CASIO FX991ES, CASIO FX-991ES plus and CASIO FX-570ES Plus, Smart Watches, cellular phones, ear plugs, transmitters, portable computers, bluetooth, and other electronic gadgets/devices. Examinees will be required to TURN OFF their mobile phone/s before entering the examination venue. Phone/s must be placed inside their transparent envelope and can only be used again upon exiting the venue;
- 2. Books, notes, review materials, and other printed materials containing coded data/information/formula are not allowed inside the testing center premises.
- 3. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
- 4. Bringing of the said items inside the examination venue will be considered as CHEATING or an ACT OF DISHONESTY. If an examinee is found guilty, his/her examination papers shall be cancelled and shall either be suspended or debarred from taking future examinations
- 5. Report to the school/building assignment before 5:30am on the first day of examination to verify your room and seat number. <u>Be punctual. Late examinees will not be admitted.</u>
- 6. Examinees are required to wear the following attire every examination day:
  - MALE: White polo shirt with collar (without any seal, logo or mark). Decent pants or slacks.
  - FEMALE: White blouse or shirt with collar (without any seal, logo or mark). Decent slacks or skirts. Pony-tailed long hair.
- 7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.
- 8. Avoid using Plastic PET Bottles, plastic wrappers and food packages. This is in observance with the eco-solid waste initiatives of our partner schools. Tumblers may be used but subject for inspection.
- 9. Personal belongings brought by an examinee shall be for his/her own account. The PRC will not be answerable for any such item or personal belonging that might be lost during the examination without fault or negligence on its part.
- 10. This licensure examination will be administered through a Computer-Based Licensure Examination (CBLE).

- 1. Check or verify your school/building assignments at the PRC official website (<u>www.prc.gov.ph</u>) or through the Notices/Announcements to be posted at the PRC premises two (2) to three (3) working days before the date of examination.
- 2. Report to the school/building assignment before 5:30 a.m. on the first day of the examination to verify your room and seat number. Be punctual. Late examinees will not be admitted.
- 3. Examinees are required to wear the following attire every examination day:

1. Male Examinees	-	White polo shirt with collar (without any seal, logo or mark) Decent pants or slacks
2. Female Examinees	-	White blouse or shirt with collar (without any seal, logo or mark) Decent skirt or slacks

- 4. Bring the following on examination day:
  - a. Notice of Admission
  - b. Official Receipt
  - c. One (1) piece metered-stamped window mailing envelope
  - d. Two (2) or more pencils (No. 2)
  - e. Ballpens with **BLACK** ink only
  - f. One (1) piece long brown envelope
  - g. One (1) piece long transparent/plastic envelope (for keeping your valuables and other allowed items)

h. NON-PROGRAMMABLE CALCULATORS (Please refer to Commission Resolution No. 1809-2024 or the "Updated List of Non-Programmable Calculators Allowed to be used in the Licensure Examinations")

# NOTE: ONLY ONE CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.

5. The following items are strictly **PROHIBITED** inside the examination premises/rooms.

- a. Books, notes, review materials, and other printed materials containing coded data/information/formula.
- b. Calculators which are programmable or with embedded functions especially CASIO FX991ES and CASIO FX-991ES plus
- c. APPLE, SAMSUNG AND OTHER SMART WATCHES, CELLULAR PHONES, EAR PLUGS, TRANSMITTERS, PORTABLE COMPUTERS, BLUETOOTH AND OTHER ELECTRONIC GADGETS/DEVICES WHICH MAY BE USED TO STORE OR RETRIEVE DATA/INFORMATION AND/OR TO COMMUNICATE FOR WHATEVER PURPOSES
- d. Bags of any kind (ladies bag, shoulder bags, attaché case, backpacks, etc.)
- e. Other examination aids not stated on this program.

All personal belongings of the examinees shall be surrendered to the proctor and shall be placed in a secured space within the examination room.

The rules on the conduct of bodily search, inspection of personal belongings of the examinees, and the seizure/confiscation of prohibited items during the licensure exam (Annex A of PRC Memorandum Order No. 57, s. 2020) shall be strictly observed.

- 6. Examinees and examination personnel are encouraged to observe the minimum health standards per DOH Circular No. 0324 (s. 2023)<sup>1</sup> throughout the conduct of the examination
- 7. Read carefully and follow the instructions on your NOTICE OF ADMISSION and EXAMINEES GUIDE.
