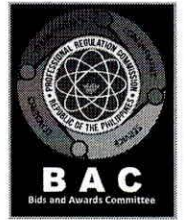

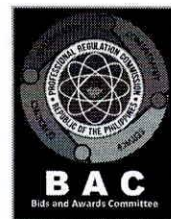

**II. Supplier/Bidder Requirements and Qualifications**

12. The winning bidder shall provide 24/7 technical support and shall provide a central toll-free hotline number and e-mail address for their technical support.
13. The winning bidder shall provide on-site support service and not carry-in to service centers on the next business day after the final remote diagnosis for delivered items in PRC-Central Office.
14. The following documents shall be submitted along with the other technical eligibility requirements:
  - a. Proof/certificate that the unit/model offered is current and not in "end of life" as reflected in the current product line in the manufacturer's official website/brochure; and
  - b. Copy of valid company IDs and certificates of the on-site support engineers and technicians showing that they can support the products offered.

**III. Warranties**

The supplier shall provide three (3)-year warranty on parts and services.

The warranty shall commence upon issuance of Notice of Acceptance of the end-user.

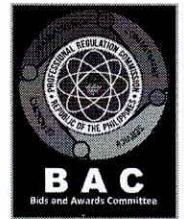
1. Compliance with the statements must be supported by evidence in a Bidder's Bid and cross-referenced to that evidence. Evidence shall be in the form of the manufacturer's un-amended sales literature, unconditional statements of specification and compliance issued by the manufacturer, samples, independent test data, brochures, etc., as appropriate.
2. A statement that is not supported by evidence or is subsequently found to be contradicted by the evidence presented will render the Bid under evaluation liable for rejection.
3. A statement either in the bidder's statement of compliance or the supporting evidence that is found to be false either during Bid evaluation, post-qualification or the execution of the Contract may be regarded as fraudulent and render the Bidder or supplier liable for prosecution subject to the provisions of ITB Clause 4.
