RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF THE PROFESSIONAL REGULATION COMMISSION (PRC) REGIONAL OFFICE XI THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF RT-PCR TEST SERVICE FOR PRC-RO XI EXAMINATION PERSONNEL FOR THE CONDUCT OF LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS FOR JANUARY 30, 2022 WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF ONE MILLION THREE HUNDRED NINETEEN THOUSAND FIFTY PESOS (PHP1,319,050.00)

WHEREAS, a Purchase Request No. 2022-01-0004 dated January 3, 2022, was received by PRC XI Regional Bids and Awards Committee (RBAC) secretariat on January 4, 2022, for the Procurement of RT-PCR Test Service for PRC - RO XI Examination Personnel for the conduct of Licensure Examination for Professional Teachers for January 30, 2022, with an ABC of PhP1,319,050.00;

WHEREAS, on January 5, 2022, the Professional Regulation Commission Regional Office XI (PRC RO XI), through its Regional Bids and Awards Committee (RBAC) conducted a public bidding for the procurement project named "Procurement of RT-PCR Test Service for PRC-RO XI Examination Personnel for the conduct of Licensure Examination for Professional Teachers on January 30, 2022, with an Approved Budget for the Contract (ABC) of One Million Three Hundred Nineteen Thousand Fifty Pesos (PhP1,319,050.00) by having its Secretariat post the Invitation To Bid (ITB) with ITB No. DVO-2022-01-001 on the website of the Philippine Government Electronic Procurement System (PhilGEPS), website of the procuring entity, and at a conspicuous place within the premises of the PRC-RO XI office;

WHEREAS, on January 14, 2022 at 2:00P.M. the scheduled Pre-Bid conference was conducted via video conferencing by the RBAC with the presence of one (1) representative from the prospective bidders namely: Ms. Ming Hyacinth Tan of Davao One World Diagnostic Center, Inc. and one (1) observer in the person of Ms. Mary Rose S. Osip of the Commission on Audit, but due to the intermittent internet connection, Ms. Osip requested for the recording of the said activity.

WHEREAS, there was no possible supplier who viewed the opportunity in the PhilGEPS website:

WHEREAS, on January 20, 2022, the majority of the PRC RO XI Regional Bids and Awards Committee Members were found positive of COVID 19 virus and had to undergo quarantine. The above mentioned procurement activity is considered urgent, since the Licensure Examination for Professional Teachers is scheduled on January 30, 2022. Hence, the RBAC members agreed to do a virtual evaluation of bids on January 26, 2022 for the Procurement of the RT-PCR Test Service for the PRC-RO XI Examination Personnel for the conduct of Licensure Examination for Professional Teachers on January 30, 2022.

WHEREAS, during the deadline for the SUBMISSION AND RECEIPT OF BIDS and BID OPENING on January 26, 2022, DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.; submitted their bid documents within the deadline;

WHEREAS, Section 30 Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examinations of bids be conducted by merely checking the presence and absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";
