RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF THE PROFESSIONAL REGULATION COMMISSION (PRC) REGIONAL OFFICE XI THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF RT-PCR TEST SERVICE FOR FEBRUARY 2022 FOR PRC-RO XI EXAMINATION PERSONNEL FOR THE CONDUCT OF VARIOUS BOARD EXAMINATIONS WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF TWO HUNDRED SIXTEEN THOUSAND FOUR HUNDRED FIFTY PESOS (PHP216,450.00) THROUGH SMALL VALUE PROCUREMENT SECTION 53.9 OF THE 2016 REVISED IMPLEMENTING RULES AND REGULATIONS OF REPUBLIC ACT NO. 9184

WHEREAS, a revised Purchase Request No. 2022-01-0005, was received by PRC XI Regional Bids and Awards Committee (RBAC) secretariat on January 20, 2022, for the Procurement of RT-PCR Test Service for February 2022 for PRC - RO XI Examination Personnel for the conduct of various Board Examinations, with an ABC of PhP216,450.00;

WHEREAS, Request for Quotation (RFQ) No. 2022-01-007 dated January 20, 2022 was posted and published to PhilGEPS website, Procuring entity website and in a conspicuous place within the premises of PRC RO XI in compliance with Republic Act No. 9184 otherwise known as the "Philippine Government Procurement Reform Act," and its 2016 Revised Implementing Rules and Regulations and sent to prospective bidders/suppliers, namely: SAFEGUARD DNA DIAGNOSTICS INC., DAVAO ONE WORLD DIAGNOSTIC CENTER, INC., and VITALAB REDMARK CORPORATION;

WHEREAS, there was one possible supplier who viewed the opportunity in the PhilGEPS website the FIA MEDICAL SUPPLY;

WHEREAS, in response to the RFQs, the DAVAO ONE WORLD DIAGNOSTIC CENTER, INC.; submitted their quotation within the deadline;

WHEREAS, Annex H (V)(D)(8)(b)(ii) of the 2016 Revised Implementing Rules and Regulation of RA 9184, procedure under Small Value Procurement, states that:

"The BAC shall prepare and send the RFQs/RFPs to at least three (3) suppliers, contractors or consultants of known qualifications. This, notwithstanding, those who responded through any of the required postings shall be allowed to participate. Receipt of at least one (1) quotation is sufficient to proceed with the evaluation thereof."

WHEREAS, on January 20, 2022, the majority of the PRC RO XI Regional Bids and Awards Committee Members were found positive of COVID 19 virus and had to undergo quarantine. The above mentioned procurement activity is considered urgent, since the first licensure examination for February 2022 is scheduled on February 3, 2022. Hence, the RBAC members agreed to do a virtual evaluation of bids on January 24, 2022 for the Procurement of RT-PCR Test for PRC-RO XI Examination Personnel for the conduct of various licensure examinations for February 2022.
