## BIDS AND AWARDS COMMITTEE

Resolution No. 2020 -03(D)

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF CONTRACT FOR THE PRINTING AND SHREDDING OF TEST BOOKLETS FOR LOT 1 - MARCH 29, 2020 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS TO VIBAL GROUP, INC. WITH THE TOTAL BID AMOUNT OF SEVEN MILLION TWO HUNDRED FIFTEEN THOUSAND EIGHT HUNDRED TWENTY SEVEN PESOS AND TEN CENTAVOS (PHP7,215,827.10)

WHEREAS, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website, the Philippine Government Electronic Procurement System (PhilGEPS) website, and in the BAC Bulletin Board for the project: Printing and Shredding of Test Booklets for the March 29, 2020 and September 27, 2020 Licensure Examinations for Professional Teachers and for the November 28, 29 & 30, 2020 Licensure Examination for Criminologists: Lot 1 – March 29, 2020 Licensure Examination for Professional Teachers, with an approved budget for the contract of Seven Million Three Hundred Twenty One Thousand One Hundred Five Pesos (Php7,321,105.00).

WHEREAS, on November 28, 2019, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective bidder, Ephesians Publishing, Inc.

WHEREAS, as a result of the discussion during the pre-bid conference, the BAC issued Bid Bulletin No. 1 dated December 04, 2019 reflecting the modifications/amendments to the Bidding Documents including the re-scheduling of the opening of bids from December 10, 2019 to December 17, 2019 at 1:00 o'clock in the afternoon (Annex "A"). The same was posted in PhilGEPS and PRC Websites.

WHEREAS, on December 12, 2019, Vibal Group, Inc. (VIBAL) submitted a letter of intention to participate and purchased the Bidding Documents.

**WHEREAS**, on December 17, 2019, the deadline for submission and Opening of Bids, only VIBAL participated and submitted its bids, however, the BAC issued a Notice of Postponement and Rescheduling of the Opening of Bids due to lack of BAC quorum.

WHEREAS, on December 18, 2019, the BAC proceeded with the Opening of Bids, VIBAL, having passed the eligibility and technical evaluation their financial bid proposal was opened, with the total bid amount of Seven Million Two Hundred Fifteen Thousand Eight Hundred Twenty Seven Pesos and Ten Centavos (Php7,215,827.10) or Fifty Eight Centavos (Php.58) per page for the printing and Two Pesos and Thirty Centavos (Php2.30) per set for the shredding. Thus, was declared as the Single Calculated Bidder and was subjected to Post-Qualification.

WHEREAS, on December 23, 2019, a post qualification was conducted at the BAC Conference Room to verify, validate and ascertain all statements made, and the documents submitted by the bidder during the submission and opening of bids in its Eligibility, Technical and Financial Envelopes.

WHEREAS, VIBAL passed the post-qualification, and was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PRINTING AND SHREDDING OF TEST BOOKLETS FOR LOT 1 - MARCH 29, 2020 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS to VIBAL GROUP, INC., with the total bid amount of SEVEN MILLION TWO HUNDRED FIFTEEN THOUSAND EIGHT HUNDRED TWENTY SEVEN PESOS AND TEN CENTAVOS (PHP7,215,827.10).
