BIDS AND AWARDS COMMITTEE Resolution No. 2020 - 06

RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION FOR HIS APPROVAL THE AWARD OF THE CONTRACT FOR THE PROVISION OF SECURITY SERVICES FOR CALENDAR YEAR 2020: LOT 1 – PROVISION OF SECURITY SERVICES IN CENTRAL AND NCR OFFICE TO ABCRMO SECURITY & INVESTIGATION AGENCY, INC. WITH A BID AMOUNT OF EIGHT MILLION TWO HUNDRED ELEVEN THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS AND EIGHTY EIGHT CENTAVOS (Php8,211,878.88)

WHEREAS, by virtue of the published invitation to apply for eligibility and to bid through Public Bidding in the PRC website, Philippine Government Electronic Procurement System (PhilGEPS), and in the Bids and Awards Committee (BAC) Bulletin Board, only ABC-RMO Security & Investigation Agency, Inc. (ABC-RMO) participated in the Public Bidding for the project: Provision of Security Services for Calendar Year 2020: Lot 1 – Provision of Security Services in Central and NCR Office with an approved budget for the contract of Nine Million Four Hundred Forty Four Thousand One Hundred Pesos (Php9,444,100.00).

WHEREAS, on January 07, 2020, a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have and was attended by three (3) prospective bidders namely. ABC-RMO Security & Investigation Agency. Inc. (ABC-RMO). Grand Meritus Security Agency Inc. (Grand Meritus), and Starcom Manpower (Starcom). However, only ABC-RMO and Aremos Security and Investigation Agency (Aremos Security) purchased the bid documents.

WHEREAS, on January 14, 2020, a bid bulletin was issued by the BAC to give an additional set of Technical Parameters with corresponding weight percentage value and to inform the bidders the new bidding schedule for the Opening of Bids. (Annex "A")

WHEREAS, during the Opening of Bids on January 28, 2020, only ABC-RMO submitted its bid containing their eligibility, technical, and financial requirements.

WHEREAS, Section 30. Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

WHEREAS, ABC-RMO having passed the eligibility and technical evaluation, the BAC opened the financial bid proposal of ABC-RMO amounting to EIGHT MILLION TWO HUNDRED ELEVEN THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS AND EIGHTY EIGHT CENTAVOS (Php8,211,878.88). Hence, ABC-RMO was declared to be the Single Calculated Bidder and was subjected to post-qualification on January 30, 2020.

WHEREAS, ABC-RMO, passed the post-qualification, was declared to be the Single Calculated and Responsive Bidder.

WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the PROVISION OF SECURITY SERVICES FOR CALENDAR YEAR 2020: LOT 1 - PROVISION OF SECURITY SERVICES IN CENTRAL AND NCR OFFICE to ABC-RMO SECURITY & INVESTIGATION AGENCY, INC. with the bid amount of EIGHT MILLION TWO HUNDRED ELEVEN THOUSAND EIGHT HUNDRED SEVENTY EIGHT PESOS AND EIGHTY EIGHT CENTAVOS (Php8,211,878.88).
