RESOLUTION NO. 1319

POSTPONING THE APRIL 2021 LICENSURE EXAMINATIONS FOR REGISTERED ELECTRICAL ENGINEERS AND REGISTERED MASTER ELECTRICIANS AND RESCHEDULING THEREOF ON SEPTEMBER 5-6, 2021 AND SEPTEMBER 7, 2021, RESPECTIVELY

WHEREAS, the Commission issued Resolution No. 1283 (s. 2020) scheduling the licensure examinations for calendar year 2021 wherein the Registered Electrical Engineers Licensure Examination (REELE) and Registered Master Electricians Licensure Examination (RMELE) were scheduled on April 20-21, 2021 & September 4-5, 2021, and April 22, 2021 & September 6, 2021, respectively;

WHEREAS, the Institute of Integrated Electrical Engineers of the Philippines, Inc. (IIEE) through the Scholarship and Academic Affairs Committee, had a series of meetings with the members of the Academe and conducted risk assessments on whether to proceed or postpone the April 2021 REELE and RMELE;

WHEREAS, with reference to the consolidated submissions of recommendations from the different universities/colleges/schools, majority of them recommended to postpone the April 2021 REELE and RMELE;

WHEREAS, the Coronavirus Disease 2019 (COVID-19) continues to pose health threats in the Philippines, which might endanger the examinees and examination personnel to high exposure risks, aggravated by the unavailability of vaccine in the country as of date, the Professional Regulatory Board for Electrical Engineering (Board) deemed it necessary to recommend the deferment of the forthcoming licensure examination;

WHEREAS, the Board and Licensure Office recommend to the Commission the postponement of the conduct of the April 2021 REELE and RMELE;

WHEREFORE, considering the foregoing, the Commission **RESOLVES** to **POSTPONE** and **RESCHEDULE** the conduct of the **April 20-21, 2021 Registered Electrical Engineers Licensure Examination** and **April 22, 2021 Registered Master Electricians Licensure Examination** to **September 5-6, 2021** and **September 7, 2021**, respectively.

RESOLVED FURTHER, that the previously scheduled **September 4-5, 2021 REELE** and **September 6, 2021 RMELE** under Resolution No. 1283 (s.2020) shall be moved to **September 5-6, 2021** and **September 7, 2021**, respectively.
