**RESOLUTION NO. 1663**

**DESIGNATING OROQUIETA CITY, MISAMIS OCCIDENTAL AS AN ADDITIONAL TESTING CENTER FOR THE SEPTEMBER 2023 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**

**WHEREAS**, Section 7 (d) of Republic Act No. 8981 or the “PRC Modernization Act of 2000” empowers the Professional Regulation Commission (PRC/Commission) to administer and conduct the licensure examinations of the various regulatory boards in accordance with the rules and regulations it may promulgate and **to determine and fix the places and dates of examinations**;

**WHEREAS**, in the exercise of this mandate, the Commission issued Resolution No. 1589 (s. 2022) on the schedule of the licensure examinations for calendar year 2023, with the Licensure Examination for Professional Teachers (LEPT) to be held on September 24, 2023;

**WHEREAS**, the Local Government Unit of Oroquieta City, Misamis Occidental requested the Professional Regulatory Board for Professional Teachers (Board) and the Commission to consider Oroquieta City as one of the testing centers for the September 2023 LEPT;

**WHEREAS**, the Commission issued Resolution No. 1493 (s. 2022)<sup>1</sup> which provides that additional testing centers for large-scale examinations outside the city or province where the PRC Regional Office is located must have at least three hundred (300) prospective examinees;

**WHEREAS**, LEPT is a large-scale licensure examination and there are more or less eight hundred (800) prospective examinees for the September 2023 LEPT in Oroquieta City, Misamis Occidental;

**WHEREAS**, PRC Regional Office X (Cagayan de Oro) has no objection to the request and recommends to include Oroquieta City, Misamis Occidental as one of the testing centers for the September 2023 LEPT;

**WHEREAS**, the Board and the Licensure Office recommend the approval of the request in order to give the concerned examinees the opportunity to take the September 2023 LEPT without unnecessary distant travel and additional expenses.

**WHEREFORE**, the Commission **RESOLVES**, as it is hereby **RESOLVED**, to designate **OROQUIETA CITY, MISAMIS OCCIDENTAL** as an additional testing center for the **SEPTEMBER 2023 LICENSURE EXAMINATION FOR PROFESSIONAL TEACHERS**.

All Commission offices/divisions are enjoined to undertake the necessary coordination to ensure the smooth and orderly conduct of the licensure examination.
