DECLARATION OF FAILURE OF BIDDING FOR THE PROCUREMENT OF VARIOUS FURNITURE AND FIXTURE: LOT 2 – TEN (10) SETS OF DOUBLE DECEKED BED WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF ONE HUNDRED NINETY-TWO THOUSAND PESOS (PHP192,000.00)

WHEREAS, the Bids and Awards Committee (BAC) published invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and in the BAC Bulletin Board for the project: Procurement of Various Furniture and Fixture: Lot 2 – Ten (10) Sets of Double Decked Bed with an approved budget for the contract of One Hundred Ninety-Two Thousand Pesos (Php192,000.00) only.

WHEREAS, on December 5, 2018, a pre-bid conference was held, to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have and was attended by a prospective bidder, Progress Home and Office Furnishings (Progress).

WHEREAS, the BAC issued Bid Bulletin No. 1 on December 7, 2018 for modification/amendment to the bidding documents (Annex "A").

WHEREAS, on December 17, 2018, during the Submission and Opening of Bids, no bidder bought the bidding documents, thus, caused the failure of bidding for the above stated project.

WHEREAS, Section 35, Rule X of the 2016 Revised Implementing Rules and Regulations (RIRR) provides for the authority of the BAC to declare a failure of bidding in cases where the bidders fail to comply with all the bid requirements as prescribed, to wit:

Section 35. Failure of Bidding

- 35.1 The BAC shall declare the bidding a failure when:
 - a) No bids are received;
 - b) All prospective bidders are declared ineligible;
 - c) All bids fail to comply with all the bid requirements or post-qualification, or x x x x (Emphasis supplied)

WHEREAS, Section 35.3 of the same IRR provide for the steps and procedure that the BAC should take in case of failure of bidding; x x x

35.3. Based on its findings, the BAC shall revise the terms, conditions, and specifications, and if necessary, adjust the ABC, subject to the required approvals, and conduct a re-bidding with readvertisement and/or posting, as provided for in Section 21.2 of this IRR.(a) (underscore supplied)



WHEREFORE, the BIDS AND AWARDS COMMITTEE RESOLVES, as it hereby RESOLVED, to DECLARE A FAILURE OF BIDDING FOR THE PROCUREMENT OF VARIOUS FURNITURE AND FIXTURE: LOT 2 – TEN (10) SETS OF DOUBLE DECEKED BED WITH A TOTAL APPROVED BUDGET FOR THE CONTRACT OF ONE HUNDRED NINETY-TWO THOUSAND PESOS (PHP192,000.00).
