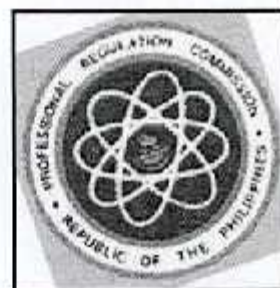

**RECOMMENDING TO THE OFFICER-IN-CHARGE REGIONAL DIRECTOR OF THE PROFESSIONAL REGULATION COMMISSION CAGAYAN DE ORO REGIONAL OFFICE X FOR HER APPROVAL THE AWARD OF CONTRACT FOR THE PROVISION OF SECURITY SERVICES 2019 WITH TOTAL BID AMOUNT OF TWO MILLION ONE HUNDRED THIRTY SIX THOUSAND FIVE PESOS AND FIFTY TWO CENTAVOS (P 2,136,005.52)**

**WHEREAS**, by virtue of the invitation to apply for eligibility and to bid through Public Bidding in the website of the Commission and in the Philippine Government Electronic Procurement System (PhilGEPS), ACD Investigation Security Agency, Inc. and VV Security Agency participated in the Public Bidding for the Security Services of PRC Cagayan de Oro Regional Office X for the Year 2019 with the APPROVED BUDGET FOR THE CONTRACT OF TWO MILLION ONE HUNDRED THIRTY SEVEN THOUSAND SIX HUNDRED PESOS (P 2,137,600.00).

**WHEREAS**, both bidders complied with the registration requirements of the Bids and Awards Committee.

**WHEREAS**, a pre-bid conference for the project was held on November 16, 2018 at the Office of the Regional Director, which was attended by ACD Investigation Security Agency, Inc. and Visa Security Agency, Inc.

**WHEREAS**, during the opening of bid documents on November 29, 2018 held at the Office of the Regional Director, ACD Investigation Security Agency, Inc. and VV Security Agency, Inc., submitted its respective eligibilities, technical and financial requirements. And it was found out that VV Security Agency, Inc. failed to submit their By-Laws which were originally submitted with the SEC under and all of its previous Corporate name and the succeeding amendments or series of amendments. Hence, VV Security Agency, Inc. was declared as "ineligible".

**WHEREAS**, ACD Investigation Security Agency, Inc. was declared to be the Single Calculated Bidder and was subjected to post qualification process to determine its compliance with all the requirements and conditions for eligibility specified in the bidding documents.

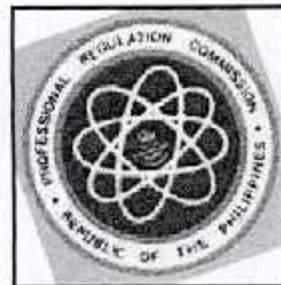
**WHEREAS**, a site inspection was conducted on December 4, 2018 for post qualification.

**WHEREAS**, ACD Investigation Security Agency having passed the post qualification, was declared to be the Single Calculated and Responsive Bidder.
