Resolution No. ILO-2020-08

RECOMMENDING TO THE HEAD OF PROCURING ENTITY OF THE PROFESSIONAL REGULATION COMMISSION ILOILO REGIONAL OFFICE, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF SAMSUNG COMPATIBLE TONER TO ANDJ BRIGHT PRINTING SERVICES WITH TOTAL BID AMOUNT OF FORTY-TWO THOUSAND PESOS (PHP42,000.00)

WHEREAS, a Request for Quotation through Negotiated Procurement was published in the PhilGEPS, PRC official website and the premises of the PRC Iloilo Regional Office on December 10, 2020 for the Procurement of Samsung Compatible Toner with approved budget for the contract in the amount of **EIGHTY-FIVE THOUSAND TWO HUNDRED PESOS (Php85,200.00)**, inclusive of VAT and all applicable taxes and fees.

WHEREAS, during the deadline and opening of bids on December 14, 2020, four (4) suppliers submitted their proposals and eligibility requirements, namely: a) Andj Bright Printing Services b) Need Ink Sales and Services c) Best Choice Enterprises, and d) Lunarchem Trading.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered "failed".

WHEREAS, upon evaluation of bids on December 14, 2020, 3:00 PM at the PRC Iloilo Conference Room, Best Choice Enterprises and Lunarchem Trading were declared "failed". Best Choice Enterprises failed to submit Omnibus Sworn Statement, and Lunarchem Trading failed to submit valid Mayor's/Business Permit, PhilGEPS Registration Number, and Omnibus Sworn Statement.

WHEREAS, Andj Bright Printing Services having passed the eligibility evaluation, the Bids and Awards Committee (BAC) considered their financial bid proposal with a bid price of **FORTY-TWO THOUSAND PESOS (Php42,000.00)** and was declared to be the Lowest Calculated Bidder.

WHEREAS, after careful evaluation, validation, and verification of the eligibility and financial proposals of the bid, the BAC found that the submission of Andj Bright Printing Services passed all the criteria for post-qualification; thus, it was declared as the Lowest Calculated Bid.
