Resolution No. ILO-2020-09

RECOMMENDING TO THE HEAD OF PROCURING ENTITY OF THE PROFESSIONAL REGULATION COMMISSION ILOILO REGIONAL OFFICE, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE SUPPLY AND DELIVERY OF GENUINE HP TONERS TO PBT TECHNOLOGY SOLUTIONS, INC. WITH TOTAL BID AMOUNT OF TWO HUNDRED NINETY-NINE THOUSAND FIVE HUNDRED SIXTY-TWO PESOS (PHP299,562.00)

WHEREAS, a Request for Quotation through Negotiated Procurement was published in the PhilGEPS, PRC official website and the premises of the PRC Iloilo Regional Office on December 12, 2020 for the Procurement of Genuine HP Toners with approved budget for the contract in the amount of **THREE HUNDRED ELEVEN THOUSAND FOUR HUNDRED TEN PESOS (Php311,410.00)**, inclusive of VAT and all applicable taxes and fees.

WHEREAS, copies of the same Request for Quotation (RFQ No. 2020-012) were sent to three (3) prospective bidders: a) PBT Technology Solutions, Inc., b) Octagon Computer Superstore, and c) Concept Computer Center.

WHEREAS, during the opening of bids on December 15, 2020, among the invited prospective bidders, only PBT Technology Solutions, Inc. submitted eligibility requirements and price quotation/proposal.

WHEREAS, Section 30, Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of bids be conducted by merely checking for the presence or absence of documentary requirements using a no-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered "failed".

WHEREAS, PBT Technology Solutions, Inc. having passed the eligibility evaluation, the Bids and Awards Committee (BAC) considered their financial bid proposal with a bid price of **TWO HUNDRED NINETY-NINE THOUSAND FIVE HUNDRED SIXTY-TWO PESOS (PHP299,562.00)** and was declared to be the Single Calculated Bidder.

WHEREAS, after careful evaluation, validation, and verification of the eligibility and financial proposals of the bid, the BAC found that the submission of PBT Technology Solutions passed all the criteria for post-qualification; thus, it was declared as the Single Calculated and Responsive Bid.
