## **RESOLUTION NO. ITB-2022-001**

RESOLUTION RECOMMENDING TO THE HEAD OF PROCURING ENTITY (HOPE) OF THE PROFESSIONAL REGULATION COMMISSION (PRC) REGIONAL OFFICE XII THE AWARD OF THE CONTRACT FOR THE PROCUREMENT OF SERVICE PROVIDER FOR RT-PCR TEST FOR EXAMINATION PERSONNEL OF PRC REGIONAL OFFICE XII WITH AN APPROVED BUDGET FOR THE CONTRACT (ABC) OF TWO MILLION TWO HUNDRED TEN THOUSAND FOUR HUNDRED PESOS (PHP 2,210,400.00) ONLY

WHEREAS, Purchase Request No. 2022-04-041 was received by PRC XII Regional Bids and Awards Committee (RBAC) Secretariat on April 22, 2022 for the Procurement of Service Provider for RT-PCR TEST FOR EXAMINATION PERSONNEL OF PRC Regional Office XII with an ABC of TWO MILLION TWO HUNDRED TEN THOUSAND FOUR HUNDRED PESOS (PHP 2,210,400.00) only;

WHEREAS, Invitation To Bid No. 2022-001 was posted and published to PhilGEPS website and PRC website on May 5, 2022 in compliance with Republic Act No. 9148 otherwise known as the "Philippine Government Procurement Reform Act," and its 2016 Revised Implementing Rules and Regulations;

WHEREAS, on May 16, 2022, at 2:00pm the scheduled Pre-Bid conference was conducted via video conferencing by the RBAC with the presence of one (1) representative from the prospective bidder namely, Ms. Ming Hyacinth Tan of Davao One World Diagnostic Center, Inc.

**WHEREAS,** on May 17, 2022 Bid Bulletin No. 1 was issued and posted in PhilGEPS website by the RBAC to correct the typographical errors: from "May 2022" to "May 2021", from "NGA, General Appropriation Act (GAA) of 2022" to "PRC-Co-22-04-011 2021 Continuing Appropriations (R.A. No. 11640)", and from "ant" to "any";

WHEREAS, two (2) possible suppliers viewed the opportunity in the PhilGEPS website namely, BIOCARE HEALTH RESOURCES INC and GREGAN 101 CORPORATION;

WHEREAS, during the deadline for the SUBMISSION AND RECEIPT OF BIDS and BID OPENING on May 27, 2022, only DAVAO ONE WORLD DIAGNOSTIC CENTER INC. submitted its respective bid;

WHEREAS, Section 30 Rule IX of the Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examinations of bids can be conducted by merely checking the presence and absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for that particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed";
