- 3. Bring the following on examination day:
 - a. Two (2) or more pencils (NO. 1 or 2)
 - b Ball pens with BLACK ink only
 - One (1) piece long brown envelope
 - d. One (1) piece long transparent/plastic envelope
 - NON-PROGRAMMABLE CALCULATORS (Please refer to Commission Resolution No. 1809 or the Updated List of Non-Programmable Calculators allowed to be used in the Licensure Examination)

NOTE: ONLY ONE BASIC CALCULATOR SHALL BE ALLOWED INSIDE THE EXAMINATION ROOM. ALL CALCULATORS SHALL BE INSPECTED AND HAVE TO BE RESET BEFORE THE START OF THE EXAMINATION.

 - Others examination aides not stated on this program.
