Resolution No. 2019 - 25

**RECOMMENDING TO THE CHAIRMAN OF THE PROFESSIONAL REGULATION COMMISSION, FOR HIS APPROVAL, THE AWARD OF CONTRACT FOR THE PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION, AND IMPLEMENTATION OF VIRTUALIZATION SOFTWARE LICENSE FOR THE TWO (2) NEW PHYSICAL SERVERS AND UPDATE OF SUPPORT AND SUBSCRIPTION OF VIRTUALIZATION SOFTWARE LICENSE FOR FOUR (4) EXISTING PHYSICAL SERVERS TO MACROLOGIC DIVERSIFIED TECHNOLOGIES INC. WITH TOTAL BID AMOUNT OF ONE MILLION SIX HUNDRED NINETY-SIX THOUSAND TWO HUNDRED FORTY-FIVE PESOS AND SEVENTY-TWO CENTAVOS (Php1,696,245.72)**

**WHEREAS**, the Bids and Awards Committee (BAC) caused the posting of the invitation to apply for eligibility and to bid through Public Bidding in the Professional Regulation Commission (PRC) website and in the Philippine Government Electronic Procurement System (PhilGEPS), and BAC Bulletin Board for the project: Procurement for the Supply, Delivery, Installation, and Implementation of Virtualization Software License for the Two (2) New Physical Servers and Update of Support and Subscription of Virtualization Software License for Four (4) Existing Physical Servers with an approved budget for the contract of One Million Seven Hundred Fifty Thousand Pesos (Php1,750,000.00) only.

**WHEREAS**, on March 19, 2019 a pre-bid conference was held to explain and clarify the bidding documents and to accommodate any inquiry which the bidders may have. This was attended by one (1) prospective bidder namely: Macrologic Diversified Technologies, Inc. (Macrologic) who consequently purchased the Bidding Documents.

**WHEREAS**, as a result of the discussion during the pre-bid conference, the BAC issued Bid Bulletin No. 1 dated March 22, 2019 reflecting the modifications/amendments to the Technical Specification in the bidding documents.

**WHEREAS**, on April 2, 2019, during the submission and opening of bids, the BAC issued a Bid Bulletin No. 2 postponing the opening of bids for confirmation of the source of budget for the project, and rescheduling the same on April 30, 2019

**WHEREAS**, Section 30, Rule IX of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184, known as the Government Procurement Reform Act requires that the preliminary examination of the bids be conducted by merely checking for the presence or absence of documentary requirements using a non-discretionary "pass/fail" criterion. If a bidder submits the required document, it shall be rated "passed" for the particular requirement. In this regard, bids that fail to include any requirement or are incomplete or patently insufficient shall be considered as "failed".

**WHEREAS**, on April 30, 2019, during the rescheduled Opening and Evaluation of Bids, Macrologic submitted its eligibility, technical and financial requirements with bid amount of One Million Six Hundred Ninety-Six Thousand Two Hundred Forty-Five Pesos and Seventy-Two Centavos (P1,696,245.72).



**WHEREAS**, Macrologic, having passed the eligibility and technical evaluation during evaluation of bid, was declared as the Single Calculated Bidder and was subjected to post-qualification.

**WHEREAS**, on May 10, 2019, a post-qualification was conducted at Macrologic Office located at 3<sup>rd</sup> Floor Macrologic Corporate Centre 9054 Molino Road Barangay Molino 3 Bacoor City, Cavite to verify, validate, and ascertain all statements made in its Eligibility and Technical Bid Envelopes during the submission and opening of bids, including the additional requirements submitted by the bidder.

**WHEREAS**, Macrologic, having passed the post-qualification, was declared to be the Lowest Calculated and Responsive Bidder.

**WHEREFORE**, the **BIDS AND AWARDS COMMITTEE RESOLVES**, as it hereby **RESOLVED**, to recommend to the Chairman of the Professional Regulation Commission, for his approval, the award of contract for the **PROCUREMENT FOR THE SUPPLY, DELIVERY, INSTALLATION, AND IMPLEMENTATION OF VIRTUALIZATION SOFTWARE LICENSE FOR THE TWO (2) NEW PHYSICAL SERVERS AND UPDATE OF SUPPORT AND SUBSCRIPTION OF VIRTUALIZATION SOFTWARE LICENSE FOR FOUR (4) EXISTING PHYSICAL SERVERS** to **MACROLOGIC DIVERSIFIED TECHNOLOGIES INC.** with bid amount of **ONE MILLION SIX HUNDRED NINETY-SIX THOUSAND TWO HUNDRED FORTY-FIVE PESOS AND SEVENTY-TWO CENTAVOS (Php1,696,245.72)**.
