Invitation to Bid for

SUPPLY, DELIVERY AND TESTING OF FIFTY (50) UNITS AIR PURIFIER WITH TOTAL APPROVED BUDGET FOR THE CONTRACT OF ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (Php1,250,000.00)

- The PROFESSIONAL REGULATION COMMISSION (PRC), through the Government of the Philippines (GOP) Continuing Appropriations Fund of FY 2020 in the amount of One Million Two Hundred Fifty Thousand Pesos (Php1,250,000.00) being the Total Approved Budget for the Contract (ABC) to payments under the contract for the Supply, Delivery, and Testing of Fifty (50) Units Air Purifier, with ITB No. 2021-23. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PRC now invites bids for the Supply, Delivery, and Testing of Fifty (50) Units Air Purifier. The project shall be completed within the duration as indicated in the Schedule of Requirements from the date of issuance of Notice to Proceed. Bidders should have completed, within the period from January 2017 prior to the date of submission and receipt of bids, a contract equivalent to at least fifty percent (50%) of the ABC that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through an open competitive bidding procedure using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".
 - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
- 4. Interested bidders may obtain further information from **PRC** and inspect the Bidding Documents at the address given below during **office hours**.
- 5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php5,000.00) per project.
 - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the PRC, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.
- 6. The PRC will hold a Pre-Bid Conference at 2:30 PM on October 8, 2021, via videoconferencing which shall be open to prospective bidders. For proper coordination, all interested bidders are hereby requested to submit their Letter of Intent to participate, including therein contact details, and send to bac@prc.gov.ph prior to purchase of Bid documents.

- 7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat at the address below on or before **10:00 AM on October 21, 2021**. Late bids shall not be accepted. All Bids must be accompanied by a bid security in the form of a Bid Securing Declaration.
 - Bid opening shall be at **3:00 PM on October 21, 2021**, at the **BAC Conference Room**, **4**th **Floor**, **Annex Building**, **P. Paredes St., Sampaloc**, **Manila**. Bidders, who will be given the link, may join the bid opening via videoconferencing.
- 8. The **PRC** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
