

	All envelopes shall:  (a) contain the name of the contract to be bid in capital letters;  (b) bear the name and address of the Bidder in capital letters;  (c) be addressed to the Procuring Entity's BAC in accordance with ITB Clause 1.1;  (d) bear the specific identification of this bidding process indicated in the ITB Clause 1; and  (e) bear a warning "DO NOT OPEN BEFORE" the date and time for the opening of bids, in accordance with ITB Clause 16.
	Bid envelopes that are not properly sealed and marked, as required in the bidding documents, shall not be rejected, but the Bidder or its duly authorized representative shall acknowledge such condition of the bid as submitted. The BAC or the Procuring Entity shall assume no responsibility for the misplacement of the contents of the improperly sealed or marked bid, or for its premature opening.
19.3	Partial bid is not allowed. The goods are grouped in a single lot and the lot shall not be divided into sub-lots for the purpose of bidding, evaluation, and contract award.  In all cases, the NFCC computation, if applicable, must be sufficient for all the lots or contracts to be awarded to the Bidder.
20.2	Only tax returns filed and taxes paid through the BIR Electronic Filing and Payment System (EFPS) shall be accepted.  Note: The latest income and business tax returns are those within the last six months preceding the date of bid submission.  Compliance with applicable Labor Laws  Compliance with all the rights and benefits of the employees under Labor Code and applicable Wage Laws such as but not limited to: service incentive leave, rest days, overtime pay, 13th month pay, contributions and remittances of SSS, PhilHealth, and PAG-IBIG shall be mandatory.
