INVITATION TO BID FOR PROCUREMENT OF SECURITY SERVICES 2022

The **PROFESSIONAL REGULATION COMMISSION – CEBU REGIONAL OFFICE (PRC-Cebu)**, through the National Expenditure Program FY 2022<sup>1</sup> intends to apply the sum of Two Million, Three Hundred Twenty-One Thousand Pesos (Php **2,321,000.00**) being the Approved Budget for the Contract (ABC) to payments under the contract for Procurement of Security Services, *ITB 2021-001*. Bids received in excess of the ABC shall be automatically rejected at bid opening.

- The *PRC-Cebu* now invites bids for *eight (8)* guards and one (1) head guard for the main regional office and its service centers in Cebu, Bohol and *Dumaguete.*<sup>2</sup> Delivery of the Goods is required for one year only. Bidders should have completed, within 2015-2020 from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bid opening shall be on 10:00 am November 23, 2021 at Hearing Room, *PRC-Cebu office*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

Post Qualification process will be on November 25, 2021, 10:00 am at the PRC-Cebu Office Hearing Room, 2<sup>nd</sup> floor, PRC-Cebu Office.

The *PRC-Cebu* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
