The Professional Regulation Commission (PRC) Regional Office VII-Cebu informs the examinees that pursuant to the approval by the Cebu City Emergency Operations Center (EOC) on September 29, 2021, the list of **ADDITIONAL REQUIREMENT** for taking the Licensure Examinations scheduled in OCTOBER 2021 are as follows:

1. NPS/OPS RT-PCR from DOH-accredited Molecular Laboratories taken 72 hours prior to scheduled examination;

OR

2. Antigen testing from DOH-accredited Laboratories (Cebu Doctor's Hospital, University of Cebu - Medical Center, Chong Hua Hospital – Fuente, ARC Hospital, Prime Care) 24 hours prior to the scheduled exam.

NOTE:

- ✓ The 14-Day Quarantine Certificate is NO longer applicable.
- ✓ Failure to bring any of the above-mentioned requirements will not be allowed to take the Licensure Examination.
- ✓ LGU Travel requirements are different from our mandatory requirements.
