**INVITATION TO BID
FOR THE PROVISION OF SECURITY SERVICES**

1. The **PROFESSIONAL REGULATION COMMISSION REGIONAL OFFICE NO. 06 (PRC RO6)**, through the **Government of the Philippines (GOP) General Appropriations Act (GAA) of 2021** with a total amount of **One Million Thirty-Nine Thousand Pesos (Php1,039,000.00)** being the Approved Budget for the Contract (ABC) for the Provision of Security Services for one (1) year for **PRC Iloilo Regional Office and Offsite Service Center – Robinsons Bacolod (ITB No. 2021-01)**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The duration of the contract to bid shall be from October 2021-November 2022, subject to the performance evaluation before the end of the contract, based on the prescribed set of performance criteria of **PRC RO6**.

2. The **PRC RO6** now invites bids for Procurement of Security Services. Security Service contract starts in October 1, 2021. Bidders should have completed for the past three (3) years from the date of submission and opening of bids, a contract equivalent to at least fifty percent (50%) of the ABC that is similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.


4. Interested bidders may obtain further information from **PRC RO6** and inspect the Bidding Documents at the address given below during **office hours**.
5. A complete set of Bidding Documents may be acquired by interested Bidders from the address below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **One Thousand Hundred Pesos (Php1,000.00)***.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The **PRC RO6** will hold a Pre-Bid Conference at **2:00 PM of September 17, 2021** via videoconferencing which shall be open to prospective bidders. For proper coordination, all interested bidders are hereby requested to submit their Letter of Intent to participate, including therein contract details, and send to ro6@prc.gov.ph on or before September 15, 2021. **Failure to submit a Letter of Intent cannot participate in the said Prebid Conference.**
7. Bids must be duly received by the Bids and Awards Committee (BAC) Secretariat at the address below on or before **1:00 PM of September 29, 2021**. All Bids must be accompanied by a bid security in the form of a **Bid Securing Declaration**.

Bid opening shall be at **1:30 PM of September 29, 2021** at the **PRC RO6 Conference Room, 2nd Floor, Gaisano ICC Mall, San Rafael, Mandurriao, Iloilo City**. Bidders, who will be given the link, may join the bid opening via videoconferencing.
8. The **PRC RO6** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
