Conformity with the technical specifications, as enumerated and specified in Sections VI and VII of the Bidding Documents. *Section VI, Schedule of Requirements, and Section VI, Technical specifications, must form part of the submission of documents. *Technical Specification shall be supported by submitting samples or evidence of such compliance, as applicable.
